CREDIT FACILITY TERMS & CONDITIONS

Zeta London Ltd (ZLL) offers credit facilities to the following conditions, which may be altered from time to time without notice.

- 1 The credit facility will apply initially for a period of three months. The facility will be extended, providing that its terms have been met in that period, and until either the Customer or ZLL give written notice of termination.
- 2 The facility is subject to ZLL's current conditions of carriage.
- 3 The Customer shall settle the full invoice amount within 10 days of the invoice date.
- 4 All payments shall be made in Pounds Sterling, by cheque or such other methods as ZLL may reasonably require.
- 5 The Credit Facility is personal to the Customer and for the use of the Customer only.
- 6 Overdue accounts may incur:
 - A Withdrawal of Credit Facilities
 - B Imposition of Deposits for further transactions
 - C Interest charges at 4% above the minimum overdraft lending rate of HSBC Bank
 - D Suspension. Suspended account transactions require individual authorization by a ZLL senior manager, which may delay delivery and response time by 48 hours. No legal or financial loss will be acknowledged or accepted by ZLL for delays due to account suspension. An administration fee off £10 will be charged for each reminder after the first.
 - E Details may be passed to credit reference agencies
 - F Outstanding payments may be pursued by a debt-collection agency
- 7 ZLL shall not be obliged to handle any shipment if the Customer's account is overdue.
- 8 The Customer shall not exceed the advised credit limit.
- 9 The Credit Facility may be withdrawn by ZLL at any time and any sums owed to ZLL shall become due and payable with immediate effect.
